All cemetery fees shall be doubled for any person who has no residential address within the Borough of Havering. Non-resident fees will apply to all cemetery fees if the deceased resided outside of the London Borough of Havering for a period longer than 5 years or more, at the time of their death. If the deceased purchased a grave whilst resident of the borough, they may be interred as resident.

In the case of a memorial permit application covering more than one deceased, if at least one of the dedications is to a resident of the borough a resident fee shall apply. If there has been no burial in the grave, a non-resident fee will be applied to any grave purchaser whose address is outside of the London Borough of Havering.
